### Poynton Relief Road lane closure 25<sup>th</sup> March

Graham the principle contractor working on the Poynton Relief Road project have informed Poynton Town Council they will be imposing a lane closure on the north side of Chester Road, adjacent to their site compound on Thursday 25<sup>th</sup> March for the duration of the bridge beams being lifted into place. The lane closure will be managed by 2-way traffic lights and is essential to facilitate the delivery and lifting into place of two precast bridge beams for the new Chester Road overbridge. They are aware of the affect traffic disruption has, so will be imposing the lane closure for only as long as is necessary. Find the letter [here](#).

### Census Day is coming!

# CENSUS 2021

Households across Cheshire East will soon be asked to take part in Census 2021.

The census is a once-in-a-decade survey that gives us the most accurate estimate of all the people and households in England and Wales. It has been carried out every decade since 1801, with the exception of 1941.

It will also be the first run predominantly online, with households receiving a letter with a unique access code, allowing them to complete the questionnaire on their computers, phones or tablets.

Census Day will be on Sunday 21 March, but households across the country will receive letters with online codes allowing them to take part from early March.

The census will include questions about your sex, age, work, health, education, household size and ethnicity. And, for the first time, there will be a question asking people whether they have served in the armed forces, as well as voluntary questions for those aged 16 and over on sexual orientation and gender identity.

Iain Bell, deputy national statistician at the Office for National Statistics, said: "A successful census will ensure everyone from local government to charities can put services and funding in the places where they are most needed.

"This could mean things like doctors' surgeries, schools and new transport routes. That's why it is so important everyone takes part and we have made it easier for people to do so online on any device, with help and paper questionnaires for those that need them."

## Healthwatch Cheshire Youth Survey

### Nitrous Oxide canisters on Tip Hill

Recently the Council Community Support Team have had several reports of nitrous oxide canisters being discarded in public areas around Poynton, most recently on Tip Hill. This appears to be a growing trend amongst young people who refer to nitrous oxide as 'laughing gas' and too many teenagers and parents are naïve regarding the dangerous effects of inhaling this substance. Parents please be aware that this type of activity is happening in Poynton. Do you know what your children are doing this evening?

### Defibrillator checks

The Council Community Support Team regularly check all of the Town Council's Automated External Defibrillators in Poynton. The weekly checks of the AEDs make sure they are in full working order should they be required in an emergency. ## Consultations

### HS2 Phase 2A West Midlands to Crewe Consultation

Poynton Town Council have responded to the above consultation. Amongst the Town Council's concerns are:

- difficulty accessing this new service for residents that live in areas that do not have a direct rail link to Crewe.
- a risk of services to London and the West Midlands from Manchester, Stockport and Poynton, Stoke and southwards being reduced.
- The proposed development of HS2 could reduce the investment in local rail which is much needed.
- HS2 could divert funding from investment in northern areas which require decent infrastructure.

### Cheshire East Air Quality Consultation

Poynton Town Council have responded to the above consultation and have expressed concerns regarding the timing of the consultation. Traffic levels have been significantly reduced over the last 12 months due the pandemic, so results may be skewed.

The consultation does not fit with the fact that Cheshire East Council have repeatedly allowed a large amount of new developments, mostly on the outskirts of settlements and so requiring the use of a car to access shops, schools and public services.
