BROOKLEDGE LANE CLOSURE

As the Principal Contractor working with Cheshire East Council on the Poynton Relief Road project, we would like to inform you we will be imposing an overnight closure of Brookledge Lane at its junction with the A523 London Road.

The closure is required to enable the safe removal of the existing traffic island and reinstatement of the ground to existing road level. The works involve breaking out kerbs and tarmac, which means some noise disturbance for local residents and businesses is unavoidable, and we'd like to apologise in advance for any disturbance caused.

The works form part of our ongoing operations to upgrade the A523 Adlington Crossroads, with all works being completed in **late December 2022**. The aim of the crossroad improvement scheme is to improve traffic flow to accommodate the expected increase in traffic levels, when the Poynton Relief Road opens to traffic.

Important information about road closure

The road closure will take place from **8pm on Monday 12th September** until **7am Tuesday 13th September**.

A signed diversion route will be in place for the duration of the road closure.
